and an event simply named H1, an event similar to the mad mile, but run round three flags simulating building corners, I believe this event was taken directly from the Fire Service training mannual of that period.

In the early sixties Ashburton was invited to compete as a guest team, due mainly to their closeness to the South Canterbury area. It was not until 1973 that the Canterbury Provincial Association placed Ashburton, Methven and Rakaia officially into the South Canterbury Sub Association, where they have since competed on a regular basis. Twizel joined the association possibly in the late seventies when they changed their status as an industrial brigade.

The Sub Associations have performed a vital role in competitions, not only in creating pre Canterbury training, but also giving experience to new teams and officials. This has proved beneficial to the parent Association, not only in maintaining team numbers, but also assisting to lessen disputes on their competition day, as the teams have by then sorted out most of their faults and rectified them.

Although competitions are the major role of the sub associations, the annual get together of the brigades in the area, form a vital link in maintaining contact and discussing mutual problems that occur from time to time. It also assists with meeting new personnel that have joined the service over the previous year, this is of significant help when a brigade is called to another brigades area to assist with an emergency situation, co-operation and understanding is able to be established immediately on a first name basis.


The success of sub associations has been well and truely proved by the number now established in New Zealand and operating effectively for their members benefit.

The forward thinking of the instigators of the sub association concept, was carried a step further in 1983, when a meeting was called to form a South Island Competitions Committee, incorporating the four Provincial Associations of Nelson/Marlborough, West Coast, Canterbury and Otago/Southland. This has also proved successful, with teams from all areas of the South Island converging on Timaru on a bi-annual basis, I believe the North Island has mooted the idea should be operating in their part of the country, who knows, we eventually see a North vesus South competition in the future on a biannual basis.

The extra competition days now being conducted by the North/Mid and South Canterbury Sub Associations has done much to improve the standars of competiton teams in Canterbury, as proved by the successes attained at the U.F.B.A. Competitions. The rivalry of Mid and South Canterbury for two trophies each year and invitations to take part in each others competitons adds that keener edge to the teams in training, as there is nothing to compare with a competition day to find the minor faults that do not always appear at practice, one coach cannot see what five judges are able to pick up during an event.

PRESENTATION OF THE CHALLENGE SHEILD

There was a very large attendance of firemen and their friends at the Sumner Town Hall last evening to witness the presentation of a silver shield, donated by the residents of Sumner, to the Canterbury Fire Brigades' Association. The Mayor (Mr J.B. Laurenson) presided. Amongst the visiting members of the executive of the association present were the president of the Canterbury Fire Brigades' Association, Superintendent Car-

son, of Lyttelton; vice-president, Captain Hean of the Addington Railway Fire Brigade; Superintendent Brambury, Christchurch Railway; the Secretary, Fireman Nicols; Ashburton V.F.B.; Foreman Clark, Kaiapoi, Superintendent Sherwood, New Brighton; Superintendent Helliwell, Spreydon; and Deputy-Superintendent Blake, Christchurch City.

The Mayor, in presenting a handsome silver shield to the president of the Canterbury Fire Brigades' Association said that the matter had really originated with Superintendent J. Carter of Sumner. The design with the manual engine on top and the Dennis pump below depicted the progress made in fire brigade matters in the Dominin.



Oxford Brigade asked about running Scout events at the competition. After a long discussion it was decided to let Oxford look into this possibility and report back to the next meeting.

Moved Rotchford Seconded 3rd Off Dickie that the winning team at the North Canterbury competition be the guest team from this Sub-Assn at the Mid-Canterbury competitions.

Carried.

It was decided that a deputation of three, the President, Secretary and Ex. C.F.O. McAllister meet the Mid-Canterbury Fire Brigades Sub-Assn. At a time and place to be aranged, to discuss the possibility of a Mid-Canterbury v North Canterbury competition. February or March was favoured as a time for running the competition.

It was decided that a circular should be sent to all brigades explaining the setting of the committee for this Sub-Assn., and asking for nominations for the committee and officials for the competitions at Oxford.

Next meeting to be a committee and team captains meeting at Oxford on 12 September at 2.00pm.

Meeting closed at 3.45pm.

SOUTH CANTERBURY

The Sub Association was formulated after the the 1956 U.F.B.A. Conference at Rotorua, during a conversation by R. McMillan, J. Baker and C. Knight, Chief Fire Officers of Temuka, St Andrews and Geraldine respectively, when the conference ruled in favour of such formations being allowed.

The concept was bought back to South Canterbury and culminated in a meeting of brigade representitives to discuss the matter. The idea found unanimous support with all brigades seeing great merit in the proposal, a small committee being set up to establish suitable trophies for competition. It is unknown by the writier if this was the first Sub Association in New Zealand, but it has been established it was the first in the South Island.

The association initially constituted the following brigades: Waimate, St Andrews, Timaru, Pleasant Point, Fairlie, Tekapo, Temuka and Geraldine, with each brigde given the option of having and A & B team compete, as the intention was to lead up to the Canterbury Provincial competitions, with training and team selections.

The first official meeting was held at Temuka on August 19, 1957, when brigade reps met to discuss a programme and set a date for the competitions, it being decided that September 28 be the most appropriate day and Temuka be the venue. Each brigade in the area to conduct the event on a rotational basis each year.

It is of interest to look back on the events that were run at these first competitions: three man disabled hose, three man union, four man hose and standpipe, four man trailer pump

There being no further nomination the Chairman declared the above elected. Invitations to hold the annual competition were then taken from the following. Burnham, Springfield, Methyen.

A ballot was then conducted the result was that Methven will hold the 1970 Competition. The runs to be the same as last year 1-4-6-9 for the trophies. The Bowman Cup to be run for Brigadesmen under 21 or members who have not yet received their 3 year certificate. Draw for places optional.

Mr J. Drummond, Akaroa, said that his Brigade has 8 keen competition members but there is no one in the Brigade to teach them. The Southbridge delegate offered to over to Akaroa with his Brigade team to help the Akaroa boys.

C.F.O. Fitzgibbon at this stage welcomed delegates and thanked them for attending as this was the first time the Lincoln brigade had been able to help the Association in any way.

The Chairman in reply thanked the Lincoln Brigade for having the meetig there and for the afternoon tea provided.

The first committee meeting to be held on Sunday 9th August at methven fire station. Meeting closed 4.30pm.

COMPETITIONS THROUGH THE YEARS

By Les McGillan

Compiled from the recollections of Past President R.W. McMillan, who was actively involved in this field of the Associations activities for well over thirty years.

The early competition events were vastly different to those of later years, much was made of the old style two wheel ladders, utilised in ladder and tower events and ladder and dummy events, rescue played a role as important as fire fighting. From all accounts these must have been spectacular for the viewing public to watch. Dressing events were also part of the early scene performed by one, two, three and four man teams. Competitors would lie on a wooden bunk arrangement in just singlet, trousers and socks. On the gun they would rise, dress themselves in tunic, helmet, belt with axle attached together with a hydrant spanner and put on their boots, then commence a hose event. This may seem easy now, but in those days at least four buttons, the old brass type, had to be fastened on the jacket, the boots had straps which had to be buckled and the strap through the keeper and sim-

ilarly with the belt, buckled and through the keeper. The last time the dressing event was held would have been about 1950, the exponent then being Jonny Fogerty from Lyttelton who had also won the event at U.F.B.A. He was the last of a long line of experts in the one man event, many of whom had come from Canterbury.

Hoses too have been adapted over the years. Up until about 1957 the lengths were 100ft and 50ft of 2½ inch flax canvas unlined hose, fortunately bight hose was used up until then, as the 100ft coil when wet was like a cartwheel. Initially the couplings on hose and standpipe had a roll type thread, like suction lengths have today, this was later changed to a finer vee thread and finally to the instantaneous couplings we know today. Think for a moment the expertise required to screw every coupling from standpipe to branch with the water chasing you along, many hours of training went into learning this art.

In the early years all events were run with dry hose from a dummy plug, as not many grounds would have had a main connected to them. At the same time all hoses were tied with a buckled strap which had to be undone before being able to be run out, not simple if one became excited, discipline brought success on the day.

The advent of the trailer pump brought in the dummy pressurised main, thus from thence onwards all events were run wet, making for more spectacular appeal and also vividly showing up major errors. This also ushered in the era of pump events to the programme, firstly the trailer pump and later the ultra lights. At one time a team could comprise six members and ingenious brigades would run a certain four in box events and change the team for pump events playing their cards to suit the strong points of each team member. Later rules brought team entries down to four named members only to alleviate this practice.

During the 75 years of the C.P.F.B.A. existance, events, rules, equipment, methods etc. have undergone dramatic changes, in keeping with those taking place with the Fire

The Chairman then asked for any information the Secretary had to hand concerning the Mid-canterbury Sub-Association.

The Secretary explained how he had tried to get information on the setting up of Sub-Association from the Secretary of C.P.F.B. Assoc. and also the views of member brigades of North and South Canterbury Sub-assoc. A letter had been sent to the U.F.B.A. seeking information and the reply was read to the meeting, plus a copy of the Hawkes Bay Fire Brigades Sub-Association rules lent by the U.F.B.A. was tabled.

The Chairman commented that the investigation for information had gone a bit further than anticipated.

Mr Drummond, Akaroa, then asked if the C.P.F.B. Assoc, had been invited.

Mr Kerr, Sumner, in speaking to the motion said he thought we should not have too big a committee.

The Sheffield Delegate thought the committee should be of 5 or 6 members, one to be an executive member of the C.P.F.B. Assoc.

It was pointed out by the Chairman that we may not have anybody from Mid-Canterbury on the C.P.F.B. Assoc. executive and should not stipulate that we must have a C.P.F.B. Assoc. executive member on the committee.

The Diamond Harbour delegate put his Brigades views on the formation of the committee, and that there should be a set of rules drawn up.

The Chairman then commented on the way North and South Canterbury Sub-Assoc. ran and that they were mainly larger type Brigades and few in number. In Mid-Canterbury there is a large number of small Brigades and that they must all be provided for.

The motion was then put "that a committee be formed to run the Mid-Canterbury Fire Brigades Sub-association" carried.

The size of the committee was then discussed. Moved Sumner Seconded Burnham "that the committee be of 7 members" carried. Moved Sumner, Seconded Diamond Harbour "that the committee select their own Chairman and Secretary-Treasurer" carried.

The rules for the Mid-Canterbury Fire Brigades Sub-Association were then discussed. Moved Springfield, Seconded Southbridge "that the C.P.F.B.A. rules that are applicable to be the Mid-Canterbury rules" carried.

FINANCE

The Chairman explained how the finance is made available to the Sub-Assoc.

Moved Diamond Harbour, Seconded Darfield "that the committee approach the C.P.F.B.A. to have the annual grant made available to the Mid-Canterbury Fire brigade Sub-Assoc. Committee instead of to the Brigade running the competition, and that the Committee fix a levy for the day of any function" carried.

Moved Southbridge, Seconded Springfield "that the levy not be more than 50c. per person" carried.

Moved Lincoln, Seconded Sheffield "that the committee open a Post office Savings bank Account in the name of the Mid-Canterbury Fire Brigades Sub-Assoc. and appoint their own trustees" carried.

At this meeting it was decided to circularise the 20 brigades in the mid-Canterbury area, stating the aims of the sub-assocn, as to try to foster a better liaison, create more enjoyment in the way of picnics, field days and competitions etc., in the area. Minutes of the last Annual meeting held at Sumner on Sunday 20th July, 1969, were read and confirmed.

The Chairman then gave an outline of the reasons for the meeting being called, the notice as sent out to Brigades was read to the meeting.

Moved by Akaroa, Seconded Sheffield, "that a vote of thanks be extended to those who have orgnaised this meeting" carried.

Service in general. Most of the changes have been practicable, such as bringing events more in line with practical fire fighting methods, making more versatile use of equipment and standardising the dress of team members.

The U.F.B.A. programme of events in the early years was drawn up by the Executive and secretary. This was the time when first Tommy Watts and then Les Warner were secretary of U.F.B.A., two expert one man dressing event exponents, whose knowledge of competition rules was legendary and their interpretation of a point was taken as final. When Bob Quinlan became secretary the concept changed, as he was a business executive with no knowledge of competitions whatever. It was then left to the Executive to clear points of enquiry on interpretation, but with the rotation of members, many of whom not being competition minded, the formation of the national Competition Panel was instituted. Three members of the service with expertise in competition work being elected every two years to oversee all aspects of competition, this has proved most successful.

The Canterbury Association during its history of competition involvement, has produced many successful team and individual performances throughout the country, it is appropriate that druing its jubilee year the National title is held by Christchurch Rescue, who have followed in the footsteps of some illustrious teams from the province.

The Association has led the country in some innovative competition concepts, firstly

All these have added much to the standard and enthusiasm of brigades in the province with their competition teams, the placings at U.F.B.A. over the years has proved this.

Competitions could not be held without the dedication provided by the people who year after year, give of their time to act as officials, the referees, judges, timekeepers, etc. many of these have gone from Sub Association to Provincial and on to New Zealand appointments, playing their parts with distinction in all theatres. No way was it the intention of this writer to delve into individuals in this narrative, but looking back over the years, how could you not mention the terrible trio, Charlie Bax, Tom Cummings and Frank Kennard, for many years they were Canterbury Competition Day. Charlie saw every penalty, no one beat Franks gun and any one not on the mark on time felt the wrath of Toms tongue. They were probably the most known and respected officials throughout the country during their time, probably the first officials selected for each U.F.B.A. Competitions every two years.

Individual brigades throughout the province who have undertaken to host the many competitions have also played a significant role in thier success. Much time and effort is put into the preparation of the running tracks and equipment, the organisation of meals and accommodation, changing facilities and social functions. It is a pleasing feature at Annual Conferences to see brigades vying for the honour to host competitions, we trust this trend will continue long into the future.

I am unsure if competitions were a significant factor in the formation of the Canterbury Association those many years ago, but like the U.F.B.A. they have played a large role in bringing brigades and individuals together on a regular friendly basis. Like the Service as a whole, once hooked on competitions it is hard to leave it alone. Many new friendships have been made on the competition grounds, long may they continue.

FULLER FIRE FLAG HISTORY—1917

On Sunday evening around 7.30pm Scoutmaster Berman of North Linwood Troop and Scoutmaster Cawley of the Radley Troop were walking through Cathedral Square when they saw smoke rising which they thought was coming from Manchester Street. Being scouts they thought they may be able to help so they ran very fast and came to what was known as 'Her Majestys Theatre' alongside the then Christchurch Town Hall. (Her Majestys was also known as 'Canterbury Hall'). They both ran down the side of the theatre and met the caretaker at a side door, on asking if they could do anything to help he said 'Yes' get upstairs and throw anything you can through the windows, they threw chairs and mirrors from the dressingrooms. Cawley then lost contact with Berman as the flames spread into the centre of the building and were fifty to sixty feet high, he then saw two firemen on the Parapet holding a hose and playing the water onto the flames.

Cawley who was only seventeen years old assisted the two Firemen in playing the water into the centre of the fire which finally subdued so they could go home, a team of firemen stayed to make sure everything was safe and Cawley got home about midnight, he was wearing his best Sunday suit, a blue one and had got it in a frightful mess.

Mr. Fuller (owner of the theatre, later Sir John Fuller) was in Wellington at this time, Cawley was reimbursed for his ruined Sunday suit by the Christchurch Fire Brigade and the Chief Fire Officer was so impressed with what the two seventeen year old Scoutmasters had done that he told Sir John Fuller all about them. Sir John Fuller then decided to present a flag to the scout movement for competition annually by teams of scouts trained at fire fighting. Although the Sydenham Troop appeared on the flag in 1917 they never took part at that time but the name appeared because Scoutmaster Cawley had his commission in the name of the Sydenham Troop when it was presented.

It was first competed for the first time in 1918.

Captain Carson suitably replied, and assured the members present that he would do his utmost to advance the interests of the Association in every way.


He then installed his office-bearers, each of whom replied, and thanked the members present for their election.

CANTERBURY-WEST COAST INTERPROVINCIAL COMPETITIONS

In 1949 the Canterbury Prov. Assocn worte to the Coast Association suggesting that Inter-Provincial competitions be held prior to the UFBA Conference which was to be held at Reefton in 1950. On 25th Nov. 1949 the West Coast Assocn replied agreeing to the suggestion. The inaugural competitions were held at Greymouth on Saturday, 11th March 1950 comprising four events:- Two Men Hose & S/Pipe, three Men Disabled hose, four men Hose & S/Pipe and the Four Men Motor (Draw for places). Thirteen teams competed, eight from the Coast (Hokitika, Cobden, Greymouth, Reefton, Grey Railway, Kumara, Otira and Runanga) and five from Canty (Rangiora, New Brighton, Lyttelton, Kaiapoi and Sumner). The competition was won by Reefton. In the evening a meeting of the two Executives was held in the Greymouth Fire Station in Boundary street, (now Demolished). Needless to say the weather was atrocious with rain as only it can in Canterbury. At the meeting it was arranged to have bi-annual competitions alternating between Coast and Canterbury venues.



RULES

Draft copies of the proposed rules of the Assoication were circulated amongst those present, and considered seriatim.

A short discussion took place on the question of subscriptions, which was proposed at £1 Is per annum as entry fee.

Superintendent Hean thought that amount might prove a drawback to small Brigades. He suggested that the annual subscription be made 10s 6d.

Past-President Superintendent Smith though it would be better to keep the subscription at £1 1s for the first year in order to cope with the initial expenses, and if there was a big balance a rebate could be made.

Captain Carson (Lyttelton) supported the suggestion. if they made the subscription £1 Is the first year, they would have an idea as to what the annual cost would be and could alter the subscription if thought fit. He moved that the subscription be £1 Is for the first year, to include entrance fee.

Superintendent Bambery seconded the motion which was unanimously agreed to.

The matter of fixing the annual subscription for subsequent years was left to the Executive, with the recommendation that it be not more than £1 ls.

The remaining rules were read and considered very suitable, and adopted.

ALL BRIGADES ADMITTED

Captain Carson asked for a ruling as to whether the Brigade of the Burnham School would be eligible for membership. The boys had a Brigade at the School, and used practically the same gear as ordinary Brigades, and personally he would like to see the boys competing with other Brigades in the Association's competitions.

Past-President Smith said they wought to encourage private Brigades.

The suggestion was received with applause, and it was afterwards decided that membership of the Association be open to all Brigades irrespective of whether they were affiliated to the U.F.B.A. or not.

Captain Carson stated that the Geraldine Brigade were having a demonstration on St. Patrick's Day, and he though they might make that their first competition.

It was explained that this was hardly practicable under present circumstances, but it was decided to write the Geraldine Brigade assuring them of the heary support of the Association, and wishing them every success.

OFFICE-BEARERS

Office-bearers for the ensuing year were elected as follows:-

President, Captain Carson (Lyttelton); Vice-Presidents, Superintendent Carter (Sumner), and Deputy-Superintendent Hunt (Timaru); Treasurer, Superintendent Tyler (Rangiora); Secretary, Lieutenant Nicholls (Ashburton); representatives from Brigades for Executive, Superintendent Bambery (Christchurch Railway), Foreman Sherwood (Sumner); Auditor, Superintendent Mealing (Kaiapoi).

A suggestion was made to hold the first competition on Labour Day, 1916, and the Secretary was instructed to write Brigades in the province to know if that date was favourable. It was also decided to call for invitations to hold the competitions.

It was decided that invitations would be accepted at the next U.F.B.A. Conference at Westport.

president of the Canterbury Fire Brigades' Association, that the invitation has been unanimously accepted and that the first demonstration in connection with the Canterbury Association will be held at Sumner next October, if possible on Labour Day.

At a meeting of the Sumner Fire Brigade last night Superintendent J. Carter presided over a full attendance. Correspondence was received from Mr Longuet, of Clifton, thanking the brigade for their efforts in connection with the recent fire. Superintendent Carter presented a report of the proceedings of the Westport Conference, in which he stated that it had been decided to hold the next demonstration at Sumner on Labour Day. A sub-committee was appointed to secure a local site for the occasion, several sections being under offer. It was decided to submit the following programme to the Canterbury Provincial Association for its approval: —

One man event, two men event, three men event and five men event. The secretary reported that a liberal prize list was being arranged. The secretary was instructed to write letters of thanks to Messrs Adams and Adams for their timely assistance with their motor-cars during the Clifton fire. A special vote of thanks was passed to Mr E. Denham for a further gift of books.

FIRST ANNUAL MEETING

The first annual meeting of the Canterbury Provincial Fire Brigade Association was held in the Timaru Fire Station on February 24th, when there was a large attendance, representative of the Brigades in the province. Deputy-Superintendent Blake (Christchurch City) presided and was supported by Vice-President Superintendent Hean (Addington), Treasurer Superintendent Tyler (Rangiora), and Secretary Superintendent Bambery (Christchurch Railway).

The Chairman expressed his pleasure at seeing such a large attendance of firemen, which was very encouraging. He gave an outline of the inauguration of the Association, and passed on to speak of the objects and advantages to be gained by affiliation with the Provincial Association. The objects were to encourage the formation of Fire Brigades and auxiliaries, to increase the efficiency of firemen, and the means of communication between Brigades, and to consider all questions affecting the interests of firemen generally. They also aimed at encouraging inventions and appliances for the more successful subjection of fires, at the circulation of directions to be observed by persons in saving themselves and their property from fire, how to treat temporary injuries received from fire, and generally to watch over, promote and protect the interests of the Fire Service. Some of the advantages and privileges to members were the sending of a delegate and team to the annual meeting and biennial demonstration, of obtaining information as to the management and working of the associated Brigades. Collectively, said the Chairman, in conclusion, the great advantage of belonging to the Association would be that members would be placed in the closest possible communication for the acquisition of knowledge on all matters relating to their position, advancement, efficiency and welfare, and by such union a feeling of strength and confidence in their resources would be generated, which could never be attained whilst remaining isolated. (Applause.)

Superintendent Bambery (Christchurch Railway), Secretary of the Association, said he had received membership fees (£1 ls) from Sumner, Ashburton, Timaru, Rangiora, and Lyttelton. The accounts amounted to about £1 10s.

The Chairman asked if there were any Brigades represented at the meeting who had not previously been represented on the Association.

Mr Collett (Waimate) said his Brigade was in a similar position, and had not yet decided whether they would join or not. They would like to know the benefits the Association offered to such Brigades as his.


The Annual Competions were held at Hanmer Domain on Saturday 8th October commencing at 8.30 am sharp.

PROVINCIAL FIRE BRIGADE ASSOCIATION

In response to the representations made by Superintendent J. Carter, of the Sumner Volunteer Fire Brigade, steps were taken in 1914 which resulted in a meeting of thirty-seven Canterbury representatives at Timaru in March last, when the first annual meeting of the Canterbury Provincial Fire Brigades' Association was held. This body was organised to encourage the formation of fire brigades and auxiliaries, to increase the efficiency of firemen and the means of communication between the brigades, to consider all questions affecting the interests of firemen generally, and to encourage inventions of appliances for the more sucessful subjection of fires. With seventeen years experience as grand marshal to guide him, Superintendent Carter felt that in Canterbury particularly something was badly needed to stimulate the men to greater efforts, and to secure this he

offered to raise funds for a shield to be competed for every second year by brigades in Canterbury.

This shield has now been completed and is on exhibition in Mr E.A. Johnson's window in Sumner, where it is attracting considerable attention. Mounted on a polished ebony panel, and fitted into a dark stained transport case, the shield, which is of silver, is surrounded with nine silver helmets and surmounted by an embossed inscription plate bearing the words, "Canterbury Provincial Fire Brigades' Association, Challenge Shield." At the top of the shield is a beaten representation of the old manual engine of 1850, while at the bottom is a similar piece of workmanship showing the Dennis pump of 1916, thus symbolising the whole progress of the fire brigade movement in Canterbury. In the centre is engraved the following: "Presented by the residents of Sumner to the Canterbury Fire Brigades' Association," While reserved for the names of the founder of the association, Superintendent J. Carter; the president, Mr W. Carson, Lyttelton; the vice-president, Mr P. W. Hunt, Timaru; the secretary, Mr Nicolls, Ashburton; and the treasurer, Superintendent A. Tyler, Rangiora. The remaining eight helmets are very effectively placed where they will hold the names of the winning teams for the next sixteen years.

It is the intention of the Sumner Brigade to formally present the shield to the president of the association in June next, when Mr J.B. Laurenson, the Mayor, will preside over the gathering. After remaining a week in Sumner it will be exhibited in Christchurch by arrangement with the maker.

When Superintendent J. Carter, of the Sumner Fire Brigade, left for Westport, he was instructed by the Mayor, Mr J.B. Laurenson, to convey the good wishes of the borough to the conference and to support the borough's invitation to the association to hold a demonstration at Sumner. Mr Laurenson has now been advised by Mr Carson, the

Blue Skies is the training establishment for the Scout Association of NZ — Canterbury area.

A special committee put forward an idea for consideration to the executive of the Canterbury Provincial Fire Brigades Association.

The concept and objective is to provide a vehicle for the gaining of knowledge and practical activities to improve the standard of firefighting in our Province.

The Executive of the Canterbury Association was confident the "Operation Blue Skies" would be successfl and a model for future training and ideas for the future, this exercise will bring together students into one brigade to carry out the duties as a single unit.

The inaugural Operation Blue Skies Training Weekend was held in September 1984 and was very successful. The operation has been repeated every seond year since then, catering for 50 students from volunteer brigades throughout Canterbury. The 1990 Blue Skies Training Weekend included members from West Coast Brigades.

Subjects covered by the wekends include: Command and Control, Explosives, Hot Fire Training, Hazardous Substances, Rural Firefighting, Accident Rescue, Fire Services Act, to name a few. Instructors at the weekend have been of a high level, including instructors from the Fire Service College, Christchurch Training Department, Department of Labour and many others.

Each weekend has a formal dinner on Saturday night, with a guest keynote speaker.

Before concluding the History of the Canterbury Fire Brigades Association may I quote a notable feature of the Association well worthy of recording: The long and continued service the Executives of the Association have given to the fire brigades in the Canterbury Province, from the time of its inception, which was in response to the representation made by Superintendent J. Carter of the Sumner Volunteer Fire Brigade, steps were taken in 1914.

The first Annual Meeting was held in the Timaru Fire Station on February 24, 1915. The first competitions were held at Sumner on Labour Day. From that year and to the present year the Association has lead the country in many concepts which are recorded in Past President R.W. McMillans recollections, which I wish to endorse. Having run in competitions with hose reels, 100 foot lengths of hose, and screw couplings, and my I quote at this stage advice given by a New Zealand Champion Competition Competitor "Ike Morrison"—that to avoid cross threading your couplings, you held the male coupling in your left hand and the female coupling in the right hand and made sure the lugs were were at six o'clock when making the connection and make a three quarter turn and you would not have a blow-out when the water came through.


